## MADISON COUNTY SANITARY SEWER AND WATER DISTRICT Contractor Registration 2014

Enclosed is the Madison County Sanitary Sewer and Water District (MCSSW) Contractor Registration Packet that outlines the items to include when registering with MCSSW to perform work installing, repairing and/or replacing water mains, sanitary sewers, and water service connections and sanitary sewer connections the MCSSW utilities.

Please be aware the ALL application forms, evidence of liability insurance, bond documents and fees MUST be included before the application can be approved and a registration card issued. A checklist is provided for your reference.

It is necessary for all contactors working on or around MCSSW utilities to have a thorough knowledge of MCSSW Rules and Regulations and to abide by those requirements while performing utility work. Copies of MCSSW Rules and Regulations are available on the MCSSW website:

## **Important Information:**

All work for new water and sanitary sewer utility connection, repairs and/or replacements of same must be permitted by MCSSW in advance of the work and all tap-in fees and permit fees paid prior to scheduling MCSSW inspection. Permit fees are provided in the Madison County Sanitary Sewer and Water Fee Schedule.

Inspection appointments for water and sanitary sewer utility connections are available Monday through Friday, excluding holidays, at pre-set times set by the MCSSW.

Meter set appointments are scheduled by MCSSW in accordance with availability of District personnel.

Inspections must be requested a minimum of one (1) working day in advance.

Contractor must obtain a permit by the applicable road authority before working in a public right-of-way.

MCSSW must be notified of any request to cancel or to reschedule taps and/or inspection appointments a minimum of one (1) working day in advance of the schedule inspection. Failure to give such notification shall result in the contractor being charged a re-scheduling fee as provided in the Madison County Sanitary Sewer and Water District Fee Schedule.
