NOTICE FOR BIDS

Notice is hereby given that bids will be received at the office of the Madison County Commissioners, 1 North Main Street, London, Ohio, 43140, on Tuesday, February 28, 2023 at 10:30 A.M., Ohio Standard Time for the purpose of **SUPPLYING ASPHALT MATERIALS** (2023 Asphalt Materials) according to specifications on file in the Madison County Commissioners' Office. The bids will be opened and read aloud immediately thereafter at the same date, time, and location.

Bids shall be submitted on forms furnished by the Madison County Engineer in a sealed envelope marked "2023 ASPHALT MATERIALS" on the outside. Sealed bids shall be submitted to the **Madison County Commissioners' Office** at the address listed above.

ASPHALT MATERIALS shall conform to the 2016 edition of the Construction and Materials Specifications of the Ohio Department of Transportation and the attached Supplemental Specifications. ODOT CMS Section 401.20, Asphalt Binder Price Adjustment shall not apply.

Bids shall have separate unit prices for all items.

Bids will be for furnishing of materials.

As specified in R.C. 153.54, a bidder (OF CHIP SEAL ASPHALT EMULSIONS ONLY) must submit a bid guaranty in the form of either:

- (1) a bond for the full amount of the bid, or
- (2) a certified check, cashier's check, or letter of credit in the amount of 10% of the bid.

Bidders shall comply with the provisions of the Americans with Disabilities Act of 1990.

Bids will be awarded to the lowest and best bidder on each individual item.

The Board of Commissioners of Madison County reserves the right to reject any or all bids and to waive any defects in the bids.

SUPPLEMENTAL SPECIFICATIONS FOR ASPHALT MATERIALS

INTENT

The purpose of this bid proposal is to provide to the Madison County Engineer equipment and materials of uniform quality and performance to promote a proven maintenance program for dura-patching and surface treating; with the herein requested materials providing a predictable performance record and compatibility with existing aggregate sources, and to promote a sound cost effective road program utilizing materials that have a predictable performance record.

SCOPE

For furnishing during the period of the contract the equipment, commodity, and service listed herein as required by Madison County.

The quantities listed here are the estimated requirements for a one year period; however, it shall not limit the actual quantity purchased during the contract period.

BID BOND – CHIP SEAL ASPHALT EMULSIONS ONLY

A 5% bid bond or certified check shall be submitted with the bid (Please note if you previously submitted a bid bond only a letter is required stating that the bid bond is still in effect).

Bid Bond or certified check shall be made payable to the Madison County Board of Commissioners.

Bid bonds or certified checks shall be returned to all unsuccessful bidders.

PERFORMANCE BOND – CHIP SEAL ASPHALT EMULSIONS ONLY

A 100% performance bond shall be supplied to secure the performance of the contract and shall be effective for a full one year period of the contract (Please note if you previously submitted a 100% performance bond only a letter is required stating that the bond is still in effect).

CONTRACT PERIOD

The materials, equipment, and services shall be delivered as ordered during the period beginning on effective date of the contract and the ending date for contract will be as follows:

SPECIFICATIONS FOR DURA-PATCHING GRADE EMULSIONS

GENERAL

Estimated Quantity: **5,000 Gallons**. Quantities are estimated, actual use in gallons will be more or less. Actual quantities used shall be paid for when approved and in conformance with these specifications.

Polymerized asphalt emulsion supplied shall be of a bituminous material having superior elastic and bonding properties. Requirements herein reflect an effort to keep as close as possible to recognized specifications while identifying certain specific requirements desired.

MATERIAL TESTING AND MANUFACTURING

Prior to the manufacture of asphalt emulsion, supplier shall provide, through an independent testing company, a statement verifying the suppliers manufacturing process, sample asphalt cement and polymers, and the method of processing the polymer into the base asphalt. Finished blend of asphalt and polymer shall be tested prior to emulsification process. An independent testing company shall inspect and seal production run consisting of a minimum of 10,000 gallons prior to shipment.

The Madison County Engineer/representative reserves the right to sample daily, one (1) gallon of asphalt emulsion from the transport vehicle prior to application. Sample shall be dated, time indicated, to be held at heated storage for future reference and or test verification.

Manufacturer/supplier shall provide the Madison County Engineer with any statements and test data obtained.

MATERIAL DELIVERY

The material shall be delivered in an insulated tanker, load size approx. 1,000 to 1,500 gallons per shipment. Temperature range shall be 160 degree F. to 190 degree F.

SPECIFICATIONS FOR TACK/FOG SEAL EMULSION

GENERAL

Estimated Quantity: **75,000 Gallons**. Quantities are estimated, actual use in gallons will be more or less. Actual quantities used shall be paid for when approved and in conformance with these specifications.

Product is to meet DOT specifications as it pertains to Tack coat and/or SS-I-H.

MATERIAL DELIVERY

The material shall be delivered in an insulated tanker, load size approx., 1,000 to 6,000 gallons per shipment. Temperature range shall be 160 degree F. to 190 degree.

SPECIFICATIONS FOR CHIP SEAL EMULSION

GENERAL

Estimated Quantity: **250,000 Gallons**. Quantities are estimated, actual use in gallons will be more or less. Actual quantities used shall be paid for when approved and in conformance with these specifications.

Sealing grade asphalt emulsion to be provided is for the use of the Madison County Engineer's Highway Forces in applying an ODOT Type 422 surface treatment. The requirements of ODOT-422.02, Materials are amended as described herein.

Polymerized asphalt emulsion supplied shall be of a bituminous material having superior elastic and bonding properties. Requirements herein reflect an effort to keep as close as possible to recognized specifications while identifying certain specific requirements desired.

The intent of this specification is to provide a polymerized asphalt emulsion liquid for chip and seal application, and/or non-polymerized.

The final selection of material will take in consideration the material cost, anticipated demurrage cost, material performance warranties, previous experience and also reserves the right to award the bid to the lowest and or best bidder. Bid/bids accepted will be from one supplier and may be for one or more types of product.

MATERIAL TESTING AND MANUFACTURING

Prior to the manufacture of asphalt emulsion, supplier shall provide, through an independent testing company, a statement verifying the suppliers manufacturing process, sample asphalt cement and polymers, and the method of processing the polymer into the base asphalt. Finished blend of asphalt and polymer shall be tested prior to the emulsification process. An independent testing company shall inspect and seal production run consisting of a minimum of 25,000 gallons prior to shipment.

The Madison County Engineer/representative reserves the right to sample daily, one (1) gallon of asphalt emulsion from the transport vehicle prior to application. Sample shall be dated, time indicated, to be held at heated storage for future reference and/or test verification.

Manufacturer/supplier shall provide the Madison County Engineer with any statements and test data obtained.

DELIVERY

Materials to be supplied shall be delivered to the work sites. A list of roads will be supplied to the successful bidder 30 days prior to the beginning of the surface treating. Ten hour working days will be in effect (07:00 a.m. - 5:00 p.m.). Chip seal operations are anticipated to begin June 5, 2023 and continue through September 1, 2023. Normally 17,000 to 23,000 gallons will be applied per day. Supplier shall provide to the county, upon request, a licensed **road worthy** 6,000 gallon insulated storage tanker. **Two and a half hours (2.5 hours) free unloading time on the job site per each transport**, additional unloading (demurrage) time will be charged at the rate bid. Re-consignment for cancelled tanker (tanker that has already left the plant) will be charged at the rate bid per tanker.

Equipment used in delivery shall be subject to approval and shall be maintained in satisfactory operating condition by the supplier. Distributor tanks and/or transport tanker shall be steam cleaned by the supplier prior to the initial shipment and upon completion of the project. Materials delivered for use shall be a temperature range of 160 - 190 degree F. Those not conforming shall be returned to the suppliers at no additional cost.

MATERIALS GUARANTEE

Samples of emulsion shall be taken from any area deemed questionable either through undesirable set times or inadequate bonding/stone loss.

Aggregate shall be separated from each sample and the residue of emulsion tested from comparison.

Materials provided that "fail" or show an excessive loss of stone within one year after application shall be replaced by the supplier, including all costs required to provide a new surface treatment application shall be borne by the supplier.
