REQUEST FOR BID

MADISON COUNTY ENGINEER - 2023 TRUCKING ASPHALT AND CHIP SEAL

Bids are for hourly rate on dump truck and driver to haul asphalt and/or chip seal aggregate to the chip spreader. Delivered to various job sites to unloading equipment throughout the county.

SPECIFICATIONS:

- 1) Trucks must have tarps;
- 2) Trucks must have minimum 18" tail overhang from rear of back tires to end of dump bed;
- 3) Trucks must have a chip hitch able to couple to a chip spreader (chip seal only)
- 4) Trucks will be paid for a minimum of 4 hrs. daily for days contracted;
- 5) Depending on cycle time, the normal hours hired will be 6:00 a.m. to 5:00 p.m.
- 6) A 15 minute clean up period will be at the end of each day when hauling asphalt;
- 7) In the event of rain out, break down, or other work delays, hired trucks will be used to stockpile stone or haul stone to other construction projects to fulfill minimum time;
- 8) If work is to be cancelled for the entire day drivers or dispatchers will be notified at/or before 7:30 a.m.;
- 9) Rates must be given on forms provided.

SECTION 3517.13**

Ohio Revised Code Section 3517.13 I(3) and J(3) requires that no agency or department of this state or any political subdivision shall enter into any contract for the purchase of goods costing more than ten thousand dollars with a corporation, individual, partnership or other unincorporated business, association, including, without limitation, a professional association organized under Chapter 1785 of the Revised Code, estate, or trust unless the contract includes a certification that the individuals named in Revised Code, estate, or trust unless the contract includes a certification that the individuals named in Revised Code Sections 3517.13 (I)(1) and (J)(1) are in compliance with the aforementioned provisions. The bidder is required to complete the affidavit provided. Failure to submit the required form with the proposal/bid package could deem the bidder's response to be non-responsive and disqualified from receiving further consideration.
